### \* Information for the data subject

In accordance with the appointment of the article 13 of the regulation of the European Parliament and of the (EU) Council No 2016/679 of 27<sup>th</sup> April 2016, the General Regulation on the protection of personal data (hereinafter referred to as "**the regulation**"), the administrator is informing as follows:

- personal data of the data subject will be processed on the basis of free consent, and namely under the above given conditions,
- the reason for giving the personal data is the interest of the data subject to receive commercial offers from the administrator, which wouldn't be possible without providing such data,
- during processing the personal data of the data subject no automated decision-making or profiling is permitted / in case that the administrator will record the data subject as an unsuccessful tenderer an automated decision about rejecting the application for employment may occur,
